



## **Class Action Summary**

## <u>Traditional Blood Reagents Antitrust</u> Class Action Settlement

If you or your business purchased Traditional Blood Reagents from **November 4, 2000 through October 19, 2015**, you may be entitled to participate in the **\$41.5 million** recovered in class action settlements.

Filing Deadline: The deadline to file a claim has passed. Dynamic Settlement Group is still filing claims for new clients.

Acceptance is subject to Court approval.

<u>Eligible Class Members:</u> Eligible class members include all persons or entities (excluding federal governmental entities) who or which, from November 4, 2000 through October 19, 2015, purchased "Traditional Blood Reagents" (defined below) in the United States <u>directly</u> from either of Immucor, Inc. ("Immucor") or Ortho-Clinical Diagnostics, Inc. ("Ortho") (collectively, the "Defendants").

<u>Definition of "Traditional Blood Reagents":</u> For purposes of this litigation, the term "Blood Reagents" includes immunohematology products designed and manufactured to test, match, detect, screen, diagnose and/or otherwise identify certain properties of the cell and serum components of human blood. This includes Traditional Blood Reagents (blood reagents primarily used to test blood manually in test tubes). In contrast, Proprietary Blood Reagents are blood reagents primarily used to test blood in automated and/or semi-automated platforms and include Ortho's ID-MTS gel products and Immucor's Capture products. This summary pertains to only Traditional Blood Reagents and does not include Proprietary Blood Reagents and/or Ortho's 0.8% red blood cell reagents.

<u>Case History:</u> Several lawsuits were filed in May 2009 alleging that the Defendants' participated in conduct that impacted the pricing of Traditional Blood Reagents. These lawsuits were consolidated before Judge DuBois in the Eastern District of Pennsylvania. At this time, the class has entered into a settlement with Immucor in the amount of \$22 million (the class period for the Immucor settlement ends on February 23, 2012) and Ortho in the amount of \$19.5 million (both settlements received final approval). The settlement funds (less expenses, noticing costs and fees) will be distributed at the completion of a claims process.
