The Defendants have agreed to settlements resolving claims that they allegedly fixed the price of liquid aluminum sulfate. In other words, individuals and businesses may have paid more for liquid aluminum sulfate.

The deadline to submit a claim form is February 15, 2020.

WHO IS ELIGIBLE TO PARTICIPATE IN THIS SETTLEMENT?

Purchasers of liquid aluminum sulfate may be eligible for compensation in this \$33.625 million legal settlement if:

- 1. You or your business purchased liquid aluminum sulfate between January 1, 1997 and February 28, 2011.
- 2. You or your business was located in Alabama, Arkansas, Arizona, California, Colorado, District of Columbia, Florida, Hawaii, Illinois, Iowa, Kansas, Maine, Massachusetts, Michigan, Minnesota, Mississippi, Nebraska, Nevada, New Hampshire, New Mexico, New York, North Carolina, North Dakota, Oregon, Puerto Rico, Rhode Island, South Carolina, South Dakota, Tennessee, Utah, Vermont, West Virginia, or Wisconsin.
